

## Application Requirements and Process Social Security Number (SSN) or Individual Taxpayer Identification Number (ITIN)

You must wait to apply for your Social Security Number until after your employment begin date and after you have been in the U.S. for at least 30 days.

**Note:** Social Security Numbers are required for all appointment titles, EXCEPT those titles listed below under ITIN number.

The SSN Letter Request can be found on Terra Dotta. The ISS Letter is only valid for 30-days. If your letter expires, please use the link above to request a new ISS Letter from our office. The Social Security Administration (SSA) Office in Madison will not accept copies of letters. Therefore, we will not provide digital copies of the ISS Letter in Terra Dotta. Please come to the ISS office to pick up the letter or request ISS send you the letter through the U.S. Mail. 3. Receive the ISS office letter indicating you are a full-time student and eligible to be employed. 4. Take the items indicated in column 2 to the local social security office found at the link below. <a href="https://secure.ssa.gov/apps6z/FOLO/fo001.jsp">https://secure.ssa.gov/apps6z/FOLO/fo001.jsp</a> . 5. A few weeks after your application, you will receive your Social Security Card in the mail. You must inform UW Payroll of this number by logging into your GLACIER online tax compliance system account and adding it to your record. You will be directed to print a new GLACIER Tax Summary Report and any tax treaty forms, if eligible. All forms must be signed and delivered to 21 N. Park Street, Suite 5101, Madison, WI 53715, as soon as possible.

If you will receive a scholarship, fellowship or travel reimbursement through UW Payroll or Accounts Payable and are not eligible for a Social Security Number, apply for an Individual Taxpayer Identification Number (ITIN) at your local IRS office as soon as possible.
